#### **Implementation**

We invite all our stakeholders to participate and support initiatives which contribute to a more sustainable world.

Through this Responsible Supplier Policy, we have established a number of requirements for those who are already or wish to become our suppliers, including key standards to comply with, for the benefit of all those directly or indirectly involved.

## Compliance

As a supplier of Colep Packaging:

- You ensure the compliance of laws, regulations, licenses, permissions, authorizations, consents and permits needed to carry out the work in a lawful, responsible and ethical way under the supplier contract and you conduct your business in a lawful and secure manner, you will:
  - Implement reasonable measures for minimizing exposure of Colep Packaging to security threats such as terrorism, crime, pandemics and natural disasters;
  - When visiting or working at Colep Packaging locations, abide by Colep Packaging's security procedures and report any security concerns to the appropriate Colep Packaging channels;
  - Implement reasonable measures to make sure that no criminal offence, including but not limited to human trafficking, drug dealing, money laundering or tax evasion takes place in relation to the supplier contract with Colep Packaging;
  - Adhere to international trade regulations and export control regulations;
  - Adhere to applicable legislation with regards to protection of personal data.
  - You comply with the standards established in Colep Packaging's Code of Conduct;
  - You conduct your business in an ethical manner refraining from corruption, extortion
    and bribery, and specifically ensure that payments, gifts or other commitments to
    costumers, government officials and any other party are in compliance with
    applicable anti-bribery laws and adhere to Colep Packaging's Ethics Charter, as well
    as disclose to Colep Packaging information regarding potential conflicts of interest
    relating to your activities as a supplier, protect all confidential information provided
    by Colep Packaging and business partners and respect intellectual property of other;
  - You provide a safe and healthy workplace for all your employees and conduct your business in an environmentally sustainable way, having a documented, implemented and auditable Health, Safety and Environment management system and quality

system and complying with applicable health and safety laws and regulations and according to Colep Packaging's HSE Policy;

- You conduct your business with respect and consideration for the environment and strive to minimize your environmental negative impact, complying with applicable laws and regulations and creating environmental benefits such as protecting and minimizing negative impacts on air, water and soil, preserving biodiversity, and assuring a responsible consumption of resources;
- You source goods and services in a responsible manner; you select your own suppliers providing goods or services directly or indirectly to Colep Packaging only if they agree to adhere to standards comparable to those set forth in this Policy;
- You keep record of all relevant documentation and provide us with supporting documentation upon request;
- In the context of our business relationship, if you or your employees believe that the
  terms of this Policy are being adhered to, or that Colep Packaging is not acting in
  accordance with its own Business Principles and Policies, we encourage you to raise
  your concerns through the Colep Packaging Ethics Direct Line (https://coleppk.com/ethics-direct-line/);
- As a supplier to Colep Packaging, we expect you to have read and understood the
  contents and requirements of this Colep Packaging's Responsible Supplier Policy
  and related Policies and comply with such requirements;

If, for any reason, you have not understood the contents of this policy or are unable to comply with the requirements, we expect you to contact Colep Packaging prior to making any delivery or providing any service.
